- Senior Pastor's Report 2024 (received for information)
 - Deana provided an overview of highlights from the past year
 - Questions:
 - Over the years we had DNA and bedrock beliefs and strategy sessions. I wonder in a post-covid era to think again about major congregation dreams and envision together what the future holds.

Deana: we all are the church and not me or the Board. No specific plans at the moment, but look out for something

- from Deana and the Board. Deana introduced the Engagement Committee
- 2. What's the status of the church in Kampala Uganda? Deana: we took up a special offering for the church and we raised \$1,500 and a member of the congregation matched it. \$3,000 went to the church and they used the money for enough 5-6 community HIV testing days. Educating the community on treatment and prevention, and also providing everyone with food
- Deana briefly spoke to the financial statements
 - Questions:
 - Talk a bit about the relationship between and decision making and sustained giving. The reason why sustained giving matters.
 - Deana: Quoting Olivia Chow "we can't spend money if we don't have" sustained giving allows us to plan for the future. To understand what's liable to be coming in and put together a budget. If sustained giving is down, there are things we would love to do that we cant do.
 - 2. Question about statement of operation. What is the gap between the deficit of 2023 and 2022.
 - James: reflected effort and work from Elevation in bringing in resource and then a bit of lull with Senior Pastor change and development activities slowed down and reflected in

the numbers. Incumbent on all of us to focus on the things and bring focus on how to move into the next phase.

3. Question relates to budget. Do you at the Board level look at the budget versus actuals?

Deana: Staff goes through every line and we do look at the items in detail

Kevin: Budget for this year was passed and vetted through Finance Committee and Board and is in place. Reflects our predictions, which is always a challenge.

4. Question about the Budget. Does the 2024 budget have a budgeted deficit?

Kevin: we had budget surpluses for many years reflective of graph seen earlier. Yes, current year budget does have budgeted deficit, but it's less than the available unrestricted funds should we need them. It's very difficult to predict, especially with the building, we complete one project and jump to the next issue. The boiler is 42 years old. It's a modest deficit and fairly consistent in what we've budgeted in previous years

5. Is there a revenue allocated to reserves?

Kevin: certain kinds of donations, we have the internal formula that a certain percent of them are moved off to reserve funds. Rainy day fund gets 10% of sustained donations. And another fund where take 10% of any bequeaths and move them off to a reserve. On our mission

and restricted funds, externally or Board restricted, portion of those, broken down in notes, note 5.

- Election of Members to the Board of Directors
 - question: how is the board balancing the skills and the fact that the board represents a true representation of who is showing up at service?

James: a strong focus was placed this year on those with strong fundraising skills as it's an important part of our community. Not a lot of people applied. It is hard work and can be thankless at times. Our objective is to represent gender and all kinds of backgrounds in a balance member. We did some recruiting in increasing diversity of the Board and were not able to include these people but keep them for next year's consideration.

- it would be helpful for us to better understand what the Board's Mandate and if there are gaps in governance in managing the current climate?
 - James: from a perspective of the Board Mandate is about strategic activities at the governance level and not about operations. Operations rest with Deana who is the CEO of the corporation and Shannon our COO. The Board firmly believe in clear duties, responsibilities, and follow up. We try to focus on things of culture.
